FEES

APPLICATION AND TESTING:

Applies to new students only, including siblings.

Covers application processing and testing for entry to grades K - 7 -- \$100.00 non-refundable.

The Griffin Academy (TGA) students applying for kindergarten will be considered returning students and not charged the application fee.

REGISTRATION:

For each returning student, during registration period 2/1/19 - 2/28/19 -- \$200.00; after 2/28/19 - \$300.00.

[TGA applicants for kindergarten \$200.00 from 3/1/19-3/15/19; after 3/15/19 - \$300.00]

Each registration must also include an enrollment deposit of \$500.00 (applied to first tuition installment, April 30).

All registration and enrollment deposit fees are non-refundable.

For new students -- \$400.00 registration fee (non-refundable) and \$600.00 enrollment deposit (applied to first tuition installment, April 30, non-refundable).

TUITION CHARGES INCLUDE extracurricular fees for all field trips, textbooks, workbooks, classroom supplies, annual student portraits, student accident insurance, and tuition refund insurance.

ENROLLMENT

For returning students, reserving a place in a forming grade for 2019/2020 is accomplished by submission of a completed Enrollment Agreement form by the student's parent/guardian(s), payment of the \$200.00 [\$300.00] registration fee and the \$500.00 tuition deposit, and enrollment in FACTS. For new students, reserving a place in a forming grade is accomplished by completion of the Enrollment Agreement form, payment of the \$400.00 registration fee and the \$600.00 tuition deposit, and enrollment in FACTS. (<https://online.factsmgmt.com/signin/3QVQ5>)

MULTIPLE STUDENT DISCOUNT: For the second student from the same family, deduct 10%; for the third student (and each additional), 15%; (Percentage based on full tuition for payment plan and grade of additional student(s).)

Note: Limited financial aid funds are available. Recipients must apply each year and complete online applications at sss.nais.org/parents; Westminster School's code is 1941 for the NAIS application. Call the Business Manager at 703-256-3620 with questions. Also required: Submit a copy of your most recent IRS 1040 form directly to Business Manager, Westminster School. All financial information is kept confidential. You are encouraged to apply early to Financial Aid in order to have any award applied properly to the first tuition payment in FACTS.
